3. Validity of offer would be for six month from the date of publication.
4. The rates quoted for supply of uniform items and tent should be inclusive of taxes, levies or any other taxes and transportation cost.
5. The payment of supply of stores will be made only after the delivery of the stores in good and serviceable condition, after that the bills will be processed by the Regional Pay and Accounts Office, Shillong.
6. The successful bidder should deposit the security money of Rs. 10,000/- by cash/draft, payable at SBI Barepani branch, Meghalaya, infavour of the Director, N.E.P.A, for which no interest will be payable. If there is any violation in the terms and conditions, the Director reserves the right to recover the same from the security money at his discretion.
7. All the papers should be signed and stamped by the proprietor / partner and with the seal of the firm stamped.
8. **The Director, NEPA reserves the right to accept or reject any or all or part of the tender at any stage without assigning any reason.**
9. The Director, NEPA, will act as arbitrator for any disputes arising out of this and his decision will be final and binding.
